### **Spare the Air Days**

All the homes within Country View were originally built with fire places and this is the season for their use. We are reminded though that when certain atmospheric conditions occur within the Bay Area, "Spare the Air" alerts are declared and fireplace use is banned. In the past, first time violators received a warning. Recently, though, the rules have been changed and first time violators can be cited and fined. Fines for repeat offenders can be \$500.00. Before using your fireplace we recommend you call 1-877-4NO\_BURN or check the internet at "Spare the Air Day" to check if an alert is in effect.

### **Burglaries on Tahiti Drive and Barbados**

There have been three robberies on Tahiti and Barbados Drives; one last summer and two this November. The police believe these are crimes of opportunity. The robbers wait for the homeowners to leave and then break in. Jewelry, iPads, and computers have been stolen.
